



Report of Activities in 2021



In 2021 we in Schola Fidentiae – School of self-confidence (SF in the next) were continuing the activities we started in October 2020. We took a few small but successful actions on our journey to develop the society as a peculiar self-confident community of people that on the base of knowledge, preservation and cognition their own history constitute the society constructed on values and principles of humanity and solidarity.

During the year we were discussing our function and vision and were preparing for creating strategic documents of our organization. We successfully changed the name, create the first informative web sites, and set the site Schola Fidentiae – Škola s(ebe)vědomí on Facebook.

In autumn we cooperated on preparation of the grant application for the financial support for the project Centre of Intercultural Dialogue within the programme Innovative use of movable and immovable cultural heritage from EHP funds and Norway, whose main holder is Religious Community of the Czechoslovak Hussite Church in Prague 4 – Michle, and other partners Khamoro, o.p.s., Romea, o.p.s., and Romano Kher – Roma Home from Oslo. The goal of the project is widening cultural and educational programmes in the space of the reconstructed synagogue in Prague – Michle, that is in present used by the Community of Albert Schweitzer CSCH, set here a space of meeting people of various ethnic, religious and life experiences, and discuss about their cultural heritage and vies of our common history and present.

At the end of the year we got a very nice present: the director of Antikomplex organization Terezie Vávrová suggested, and then with her team offered the possibility to use their office in the beautiful space of Emmaus Monastery in the wider historical centre of Prague.

I thank to all members – Růžena Ďorďová – our first chairwoman, Jana Kosáková, Věra Baumová, Marie Smutná, Barbora Batíková for their unrelenting support, energy and time, which they give to our community – entirely for free and voluntarily as well as in 2020.

And I thank to all of you who supported us in 2021 – practically, with communication and ideas, and fingers crossed. Thanks for the great financial support to Mrs. Eva Fantová.

I am looking forward to beginning to fulfil our and your expectations in the next year.

Pilot educational excursion to the place of memory – former concentration camp for Roma and Sinti in Lety near Písek


On Saturday the 25th September we in cooperation with Ecumenical Network for Youth Action, r.i., organized the first educational excursion for youth. As it was the pilot action, during which we wanted to show the director of ENYA Eva Mikulecká ways of our work at the place of memory at Lety, the count of participants was small: Eva Mikulecká, Růžena Ďorďová, Tereza Štěpková, Viktorka Oláhová a Kristián.

We prepared the tried format of one day visit to the grounds of the former camp, which starts in the exposition set by the Memorial Lidice around the year 2009 consisting of two replicas of prison quarters, and go on around the traditional memorial by the architect Zdeněk Hůla from 1995. After the explanation of what had been found out on this place in previous months we laid flowers to the memorial and Mrs. Mikulecká said a prayer on the importance of respect to the victims of violence.

On the way through an overgrown forest we went around the fence bounding the grounds of former large scale piggery, the around the disappearing picture of "Pérák", that was created in time, when the fight to demolish the piggery and commemorate the Roma holocaust victims with dignity culminated. On the place, where according to the latest archaeological research the concentration camp was, we not only reminded its history but also, thanks to the personal participation of Růžena Ďorďová in the protests in 2014 – 2017, heard how the protests were going on. In commemoration of women, men and children we altogether and each of us by himself gave a rose into the fence that still divides the grounds of the former camp into two parts. After lunch in the restaurant that had functioned for many years in the local house of culture and municipal office, we shortly reflected the visit of the former concentration camp – children painted pictures of their impressions and designs of what should and could be on the place, how could be the grounds adapted for the public after the demolition of the piggery.

On the way back to Prague we stopped on the cemetery in Mirovice and honoured the memory of the prisoners, especially small children having dead in the concentration camp in Lety near Písek.







Delayed Memories of Evelina Merová

At the very end of 2021 we managed to keep the promise fulfil the wish of Mrs. Evelina Merová: to publish the third edition of the book of her memories of childhood and then youth spent in Nazi concentration camps of the World War II.

"I was eleven in Prague, twelve in Terezín, thirteen in Osvětim, fourteen in a dead march," summarizes the author her life lapidary in one sentence. She survived and spent the last months of war in inconceivably difficult conditions, ill, starving, devastated by the tear of death.

The author of Delayed Memories was born in 1930 in an assimilated Jewish family. The peaceful family life, financial background and as a coulisse Prague, "the most beautiful city in the world", seemed to be a guarantee of the next predictable decades. In the late 1930's were gaining momentum: the first months of the Nazi occupation mean increasing discrimination of Jews, loss of property, humiliation and insecurity. The deportation to Terezín and then to Osvětim followed.

The liberation found Evelina in the Eastern Prussia, from where she was evacuated in a Red Army train to USSR. An army doctor took on and then adopted her. Four decades of life in the Soviet Union followed, with a new identity and old memories, which no one wanted to hear. The frame of the narration here is formed by the war destroyed and then been newly built Leningrad. Being Jew had to be kept secret, because in the Stalinist regime is was a stigma. The daily life is determined the ideology, poverty, which is was passed off as a welfare by the communist regime, and the omnipresent fear. However, she was experiencing great private happiness with her husband and children.

The author tells about three faces of the 20th century in tree political regimes engagingly and factually, with a cultured language, with admirable balance, with awareness of real life values. She nowhere succumbs she tries to understand, excuse, forgive. She tells not to retaliate, but for her children, grandchildren – and we maybe – to know.

The book was published by the publishing house Barrister & Principal.

II. Basic Accounting Principles

II. 1. Fixed Assets

The organization has no fixed assets.

In long-term tangible assets the organization would register tangible assets with the shelf life longer than 1 year and the purchase price more than CZK 40,000, and would keep it in accounts of long-term assets and in balance sheets.

Tangible assets of the purchase price less than CZK 40,000 would be kept and charged in costs. tangible assets of the purchase price more than CZK 10,000, but less than CZK 40,000 with the shelf life longer than 1 year would be registered in the account Other long-term tangible assets.

In long-term intangible assets the organization would register intangible assets with the shelf life longer than 1 year and the purchase price more than CZK 60,000.

Intangible assets of the purchase price less than CZK 60,000 would be registered in the costs. Intangible assets of the purchase price more than CZK 10,000, but less than CZK 60,000 with the shelf life longer than 1 year would be registered in the operational records.

Interests are not included in the purchase price of log term assets.

Separate tangible movable assets would be depreciated for a period of 5 years.



II. 2. Securities and Shares

The association Schola Fidentiae - Škola s(ebe)vědomí, z.s. registers - owns neither securities nor share certificates nor other shares.

II. 3. Supplies

The association Schola Fidentiae - Škola s(ebe)vědomí, z.s. registers - owns goods – printed matters – books of the total price of the inventory 26385.60 CZK of the stock price.

II. 4. Receivables

Receivables would be priced at its creation with the nominal value. The organization does not normally constitute adjustments. The members of the organization can decide about the possible constitution of an adjustment.

II. 5. Transactions in Foreign Currency

Assets and liabilities acquired in a foreign currency, would be priced in Czech Crowns according to the exchanging rate valid as of the date of their arising (declared by ČNB on the previous working day). They have not occurred in the organization yet.

II. 6. Accruals

The organization would account for the costs of future periods. Through costs of future periods it would distinguish timewise costs related to other time periods. Annually repeating costs and costs insignificant in its price, i.e., up to 5,000 CZK, will not be distinguished.

The organization would account for the revenues of future periods. So far no such folder has occurred.

II. 7. Gratuitously Acquired Long-term Assets, Investment Subsidies and Donations

In equity in the account of the group 901 – Equity, the organization would account for the sources of acquisition of free of charge acquired log term assets, as well as for investment subsidies or special purpose investment donations. This amount would then be dissolved by into the account of group 648 – Accounting of funds at the same time as the depreciation is posted.

In the association Schola Fidentiae - Škola s(ebe)vědomí, z.s. neither long-term free of charge acquired assets nor investment subsidies and gifts occurred.

II. 8. Public Collection

Schola Fidentiae - Škola s(ebe)vědomí, z.s. does not and did not organize any public collection.

II. 9. Accepted Donations

In the case of received donations, the organization accounts for received individual donations, namely by direct entry to the credit of account 682 and to the debit of account 221 – Bank account, or 211 – cash register. Schola Fidentiae - Škola s(ebe)vědomí, z.s. in 2020, received financial gifts - donations from individuals in the amount of CZK 107,941.70 and membership fees in the amount of CZK 1,200.



II. 10. Accepted Subsidies

Accepted subsidies are funds provided from public sources, i.e. mainly from the state budget, from the budgets of territorial self-governing units, from the state budgets of foreign countries, etc.

The association would account for these funds upon receipt in liability accounts of group 34, or directly in revenues on account 691 - Subsidies. In the case that the entire amount of the subsidy was not spent by the end of the year, the remaining amount would be reported as a liability on the account of group 34 or as revenue for future periods on the accounts of group 38. In the event that more was spent within the subsidized project than was so far received as part of the subsidy, the organization would debit to group account 385 - income of future periods in favour of account 691 - Subsidies, so that the economic result from the subsidy is always zero. Schola Fidentiae - - Škola s(ebe)vědomí, z.s. has not yet received any subsidy.

II. 11. Own Equity, Own Resources

Own resources in the amount of CZK 101,393.90 consist of a cash deposit - donations included in the price.

II. 12. Income Tax

The organization is a public benefit taxpayer in accordance with §17a of Act No. 586/1992 Coll., on income taxes, as amended (hereinafter only ZDP).

The organization applies the exemption according to §18 paragraph 1 and §19b paragraph 2 b) ZDP whenever possible. The accounting unit had income only from the main activity and received donations, these incomes are not subject to income tax.

None.

III. 2. Shares, Share Certificates, Bonds

The association Schola Fidentiae - Škola s(ebe)vědomí, z.s. owns neither share certificates nor bonds nor shares, it owns no share in other organizations.

The organization does not register any such debts.

III. 4. Long-Term Liabilities

The organization does not record any long-term liabilities with a maturity of more than 5 years from the balance sheet date.

Except for minor assets of negligible value, the organization does not record assets not listed in the balance sheet..

The organization does not record any liabilities that were not reported on the balance sheet as of the balance sheet date.

The association Schola Fidentiae - Škola s(ebe)vědomí, z.s. has no employees and it did not pay any rewards or wages.

The organization is not subject to the obligation to audit the financial statements.
